Participation

The proposed films will be viewed by our selecting committee, in order to participate to the 9th Vannes European Film Meetings. The Meetings will take place from **March 31st 2010 to April 6th 2010**. The condition required from the competitor is to accept the terms of the regulation. If the visual aid is considered unsuitable, the film will be withdrawn from the competition.

Registration

The registration is free of charge. The files must be dutifully filled in, undersigned and imperatively forwarded before **December 31st 2009** to the following address :

Selecting Criterias

Documentary film : **a first film** produced or subsidized. It must be a recent one, realized before January the 1st 2008.

Maximum length : **60 minutes**.

Screening media : DVD, Beta SP, DV cam.

Selection

The result of the selection will be notified by e-mail **from the 24th of February 2010 onward**. The **French subtitled** screening media - DVD, Beta SP, DV cam must be sent to the association **before the 5th of March**.

Prizes

The jury awards 2 prizes :

- 900 € by The Conseil Général du Morbihan (Morbihan County Council).
- The disposal, for a period of 30 days, of a digital camera offered by a computing firm, Digital 6.
